Roles of Internal Complaints Committee (ICC)

- The complainant shall submit a written and duly signed complaint to the Presiding officer of the ICC.
- If the case falls outside the view of the cell, the complainant will be informed.
- If the case comes under the view of the cell, the Grievance Redressal Cell shall have a discussion with the Head of the Institution before decision.
- The Committee shall recommend the penalties/action to be taken against any person found guilty of having sexually harassed the complainant (If any).
- The Committee shall search into the truth of any allegation against the complainant.
- The Committee shall recommend the penalties/action to be taken against persons found guilty against the complainant.
- The Committee shall recommend appropriate support (psychological, emotional & physical) for the victim.
